I. MAPS 3 Convention Center and Hotel

- Convention Center Site Led acquisition team. 23 parcels acquired; 2 in condemnation process.
- Convention Center Hotel
 - Council approves negotiations with Omni. Begin negotiations & details of term sheet and other documents.
 - o Began process of site acquisition.
- Participate in identification of recommended site for parking garage to serve convention center, MAPS 3 Park, Chesapeake Arena & Convention Center Hotel.
 - Research possibility of private development in conjunction with garage.
 - Begin discussions with OG&E about possible participation in parking garage development.
